**Livability Kenway Court is a residential, community focused care home in Southend-on-Sea. The service supports disabled people and people with learning disabilities. People that live at the home have a lot of individual choice, with active support from staff. Our service offers nursing support to those with complex needs.**

We take a person-centred, flexible approach. We know that everyone's needs and aspirations are different – that all sorts of things add up to a flourishing life. Together, with the people that use our services, we create bespoke care plans that give people choice and control over their own lives.

Livability Kenway Court is a service that focuses on prevention, offering specialist care onsite. An example of this is where we've supported residents with pressure ulcers, avoiding hospital admissions.

## What can you expect?

### About the home

Our accessible and spacious environment provides modern facilities, communal and individual spaces for people that live at the home.

### These include:

- Nursing care
- 24 individual rooms
- Ensuite/individual wash facilities, toilets and level-access showers
- Accessible courtyard and garden spaces
- Self-decoration of rooms - residents can choose their preferred colour scheme
- 3 communal bathrooms with adjustable bath and sluice
- 2 communal lounges with TV, video and music system
- Laundry room, 2 large washing machines and 1 large tumble dryer
- Lift and automatic doors throughout the building
- Portable hoists, profiling beds and wifi in all rooms
- Eyegaze and voice-activated technology

## Community connections

### Transitions back into the community

Our prevention model means that if people aren't ready to go straight home or back to supported living from hospital, we can be there to offer nursing care until the person is ready.

### Recreation

With an active network of supporting services and community partners, people that live at Livability Kenway Court enjoy opportunities to pursue a wide range of recreational activities in the local area. The home is well situated, within easy reach of the town centre, seafront, parks, library, museum, cinema, theatre and more. The area is served by a good train service.
